TERMS AND CONDITIONS

A. Schedule to Conditions of Entry

1. <u>Organiser:</u>	Nestlé Products Sdn. Bhd. [197901000966].
2. <u>Promotion:</u>	PERADUAN CUTI-CUTI RAYA DENGAN DEAR NESTLÉ.
3. <u>Promotion Period:</u>	The Promotion starts at 00:00:00 on 17/03/2023 and closes at 23:59:59 on 18/05/2023.
4. <u>Eligibility:</u>	<p>a. The Promotion is a Dear Nestlé new member recruitment program and is open to all legal residents of Malaysia with a valid identification document, aged 18 years and above as at the start of the Promotion Period. Participants must register as a NEW Dear Nestlé member on the Promotion Website during the Promotion Period.</p> <p>b. The registration must be submitted on the Promotion Website Registration Form at: https://registration.nestle.com.my/cuti-cuti-rama-2023-DN ["Promotion Website Registration Form"]. The Organiser shall reserve the right to request evidence of identification documents.</p> <p>c. 5. <u>Entry Method:</u>	<p><u>Entry submission via Promotion Website Registration Form:</u></p> <p>a. <u>NO PURCHASE</u> is required to participate in the Promotion. Complete all mandatory details required as stated in the Promotion Website Registration Form and click "Submit".</p> <p>c. Each Participant may only register once as a Dear Nestlé Member and each unique NEW Dear Nestlé Member that registers via the Promotion Website Registration Form is ONLY eligible for one [1] Entry submission only. The Organiser shall reserve the right to disqualify any duplicated Entries received.</p>

The Organiser shall reserve the right to request for evidence of identification documents. Failure to produce upon request will result in disqualification and prize forfeiture.</p>
6. <u>Entry Deadline:</u>	All Entries must be received by the Organiser on or before 23:59:59 on 18/05/2023. All Entries received outside the Promotion Period will be automatically disqualified.

There is a total of one hundred and ninety eight [198] Weekly Prizes to be won throughout the Promotion Period.</p> <p>c. 8. <u>Judging Details – Weekly Prizes:</u>	<p>a. As part of the Weekly Prize Finalists' selection process, the Organiser will allocate serial numbers for each Entry according to date and time received and approved by the Organiser to be a successful Entry each week, throughout the Promotion Period [each a "Qualified Entry" and collectively the "Qualified Entries"]. A set of serial numbers will be allocated for the Qualified Entries starting from serial number "1".</p> <p>b. Each week the serial numbers allocated to each Qualified Entry will be tabulated and added up to derive the total number of Qualified Entries ["Total Weekly Qualified Entries"]. Assuming that the Total Weekly Qualified Entries for Week 1 is 2201, the Organiser will compute and select based on the following:</p> <p>i. Selection of twenty two [22] Weekly Prize Finalists: $2201 \div 22 = 100.05$. Since dividing 2201 with 22 will result in a number with decimal value, the number 100.05 will be rounded down to 100. The following 22 Participants with Qualified Entries of the week bearing the following serial numbers will be selected as the Finalists: 100*, 200*, 300*, 400, 500, 600, 700 and so forth [*computation example: 100, $100+100=200$, $200+100=300$].</p>

<p>10. <u>Judging Details</u> <u>– Main Prizes:</u></p>	<p>a. As part of the Main Prize Finalists’ selection process, ALL Qualified Entries collected and processed by the Organiser during the weekly Finalists’ selection process and throughout the entire Promotion Period will separately be allocated a set of serial numbers starting from serial number “1”.</p> <p>b. B. Conditions of Entry

1. Introduction

- 1.1 This Conditions of Entry are to be read together with the Schedule to Conditions of Entry. To the extent that there is any inconsistency between these conditions of entry and the Schedule to Conditions of Entry, the Schedule to Conditions of Entry prevails. The Conditions of Entry and the Schedule to Condition of Entry shall collectively be referred to as the “Terms and Conditions”. Each capitalized term not otherwise defined herein shall have the meaning ascribed to such term in the Schedule to Conditions of Entry. Defined terms will be used singular or plural as the case may be.
- 1.2 The Organiser reserves the right in its sole discretion, without prior notice, and without any liability to any person, at any time to change the Terms and Conditions including to change the Promotion Period, make Prize substitutions, cancel, terminate or suspend the Promotion in whole or in part. In the event of any changes to the Terms and Conditions, Participants agree that their continued participation in the Promotion will constitute their acceptance of the Terms and Conditions (as changed).

2. Promotion Entries

- 2.1 By submitting an entry to the Promotion, Participants are deemed to have understood and agreed to be bound by the Terms and Conditions.

- 2.3 Proof of submission of an Entry is not proof of receipt, and the Organiser shall not be liable for any delay, lost, damaged and/or non-receipt of submissions. 3. Eligibility

- 3.1 Where the eligibility age prescribed in the Schedule to Conditions of Entry is below the age of eighteen (18), Participants are required to obtain the written consent (in such form as may be prescribed by the Organiser), from their parents/legal guardians before participating in the Promotion and submitting any personal information.
- 3.2 The Organiser may require a Participant to provide proof of eligibility to participate in the Promotion including without limitation, identification documents, and the written consent of parents/legal guardians in the case of Participants below the age of eighteen (18) years.

4. Ineligibility

The following groups of persons shall not be eligible to participate in the Promotion:

- 5.1 The following entries will be disqualified:
- (a) unclear, incomplete, duplicate, copies, illegible or incorrect entries; incorrect products and/or

- 5.2 In addition, the Organiser reserves the right to disqualify any Participant that:
- (a) undermines, has or attempted to undermine the operation of the Promotion by fraud, cheating or deception; and/or
 - (b) are not eligible or unable to provide proof of eligibility to participate in the Promotion for verification by Organiser when requested.
- 5.3 In the event of a disqualification after a Prize has been awarded, the Organiser reserves the right to demand for the return of the Prize or payment of its value from the disqualified Participant.

6. Prizes

- 6.1 The Organiser, its agents, sponsors and representatives shall have no liability to any Participant who defaults in collecting the Prizes in accordance with the Prize Claim/Delivery Date in any respect whatsoever. 9. Indemnity

Each Participant agrees to indemnify, release and hold harmless each of the Organiser, its holding, subsidiary or related companies as defined in the Companies Act 2016 (“Nestlé Malaysia Group”), directors, officers, employees, agents, sponsors and/or representatives against any and all losses, rights, claims, actions and damages (including special, indirect and consequential damages) arising from or incurred as a result of the Participant’s participation in the Promotion, acceptance of any Prize, and/or the use of the Participant’s entry and/or likeness in connection with the Promotion or violation of the Terms and Conditions.
